#### **OVERVIEW**

City Law College, Dimapur, established in 1994 under the motto *Justice for Equality*, is located at Burma Camp, Dimapur, Nagaland – 797112, opposite Veterinary Colony and near NCRC Sumi Church and Lungmen Fellowship. The institution is permanently affiliated with Nagaland University since 2009 and has been approved by the Bar Council of India since 2002. It is governed by the City Law College Welfare Society, which is overseen by a seven-member board led by a chairman-cum-Administrator.

The college was founded with the vision of making quality legal education accessible within Nagaland, particularly for students unable to pursue law outside the state. Over the past three decades, its alumni have established themselves in various roles, including the judiciary, advocacy, chamber practice, academia, and government service.
